

RESOLUTION NO. 2011-08

A RESOLUTION of the City of Bainbridge Island, Washington relating to the imposition of Business License Fees by the City, and amending Section 2 of the Bainbridge Island Fee Schedule.

WHEREAS, in 1992 the City Council passed Ordinance No. 92-10 which, in part, authorized the City Council to set fees for business licenses by resolution; and

WHEREAS, at a Special City Council Meeting on October 19, 2010, the City Council passed a motion to increase business license fees to a flat \$65.00, and the Bainbridge Island Fee Schedule was amended accordingly;

WHEREAS, City Council would like to simplify the fee schedule further to clarify the penalty for late payments, now therefore,

THE CITY COUNCIL OF THE CITY OF BAINBRIDGE ISLAND, WASHINGTON, DOES RESOLVE AS FOLLOWS:

SECTION 1. Section 2 of the Bainbridge Island Fee Schedule is amended to read as follows:

2. BUSINESS LICENSES

BUSINESS LICENSE – INITIAL APPLICATION

~~If License Applied for Before Business Commences~~ \$65.00
~~If License Applied for After Business Commences~~ \$130.00

BUSINESS LICENSE – RENEWAL

~~If renewed prior to March 1~~ \$65.00
~~If renewed on or after March 1~~ \$130.00

BUSINESS LICENSE – PENALTY

10% of fee per month delinquent after March 15 but not more than the license fee for each year owing (\$6.50 per month up to a maximum penalty of \$65.00)

SPECIAL BUSINESS – AMUSEMENT GAME \$25.00
(BIMC 5.12. Billiard, Pool, and Foosball. License expires 12/31 of each year.)

SPECIAL BUSINESS – JUKEBOX \$100.00 +
(BIMC 5.28. License expires 12/31 of each year.) \$10.00/jukebox

SPECIAL BUSINESS – GAMES OF SKILL \$25.00 +
(BIMC 5.24: Includes video games. Expires 12/31 of each year) \$50.00/game


SPECIAL BUSINESS – CABARET \$60.00
(BIMC 5.16. Applies to businesses with live entertainment.
License expires 12/31 of each year.)

SPECIAL BUSINESS – PENALTY 10% of fee per month
(Ordinance 92.10) delinquent

SECTION 2. This Resolution shall take effect and be in force on and after April 27, 2011.
