

## NARRATIVE

On 10/26/2024, at approximately 1759 hours, I was dispatched by CENCOM to 4759 Lynwood Center RD NE (Walts Market) regarding a hit and run motor vehicle collision.

Driver 2 stated at approximately 1715 hours, she parked her vehicle in front of Walts Market, and went inside to shop. Driver 2 stated she parked her vehicle in the parking stalls closest to the building and just left of the entry/exit doors to Walts Market. Driver 2 stated she returned to her vehicle at approximately 1720 hours and noticed fresh damage to the driver side door of her vehicle that was not there before she went inside the store. Driver 2 stated she drove home and talked with her son about what happened. Driver 2 stated her son told her to go back to Walts Market and ask if they have surveillance cameras. Driver 2 stated she drove back to Walts Market and the employee on site [REDACTED] told her they only have interior cameras.

Driver 2 stated after speaking with [REDACTED] she noticed the two Donate Kitsap trucks in the parking lot that were there before she left the first time. Driver 2 stated she remembered the male subjects associated with the Donate Kitsap trucks staring at her when she came out of the store to get in her vehicle. Driver 2 stated she took pictures of the Donate Kitsap trucks license plates and the associated male subjects saw what she did. Driver 2 stated the boss of the male subjects came over to her and told her they saw someone hit her vehicle earlier. Driver 2 stated the Donate Kitsap employees told her a Volo type SUV was parked next to her driver side and struck her vehicle when backing out to leave. Driver 2 described a male that came in the store after her, checked out before her, and leave before her to the Donate Kitsap employees. Driver 2 described this male as a white male, approximately 30 years of age, approximately 5'11"-6'0" tall, medium build, wearing a bluish green shirt. Driver 2 stated the Donate Kitsap employees stated the male she described is the one that was parked next to her and hit her vehicle when backing out.

Driver 2 stated she did not get any contact information from the Donate Kitsap employees. Driver 2 stated there was a white male, approximately 6'0 tall, and wearing glasses who was the boss. Driver 2 stated there was a Latino and a Native American male. Driver 2 stated a black male in his 50's is the one who saw the collision.

Officers took pictures of Driver 2's vehicle and later uploaded them into Evidence.com. [REDACTED] contacted the owner of Walts Market "[REDACTED]" who stated he would check surveillance cameras tomorrow to see if they captured the incident and let the Bainbridge Island Police Department know what he finds. Officers will follow up with [REDACTED] for video evidence and Donate Kitsap to try and obtain a statement from the male who witnessed the incident.
