which is controlled with stop signs on Hidden Cove RD. SR 305 traffic does not stop at this intersection.

Vehicle 2 was traveling south on SR 305, approaching the intersection with Hidden Cove.

Vehicle 1 was traveling west on Hidden Cove RD, and came to a stop at the intersection with SR305,

The northbound traffic was moderate to heavy. The witnesses were in a vehicle at the same stop sign as Vehicle 1. The witnesses were intending to turn right, onto north bound SR 305. Vehicle 1 was intending to cross SR 305 and continue westward.

During a break in northbound traffic, both Vehicle 1 and the Witness vehicle entered the intersection,

During a break in northbound traffic, both Vehicle 1 and the Witness vehicle entered the intersection, the Witness vehicle turned north, and Vehicle 1 crossed the northbound lane into the southbound lane.

Vehicle 1 was struck on the front passenger side by Vehicle 2's front end.

Vehicle 2 came to rest facing north west, against the guardrail on the southwest corner of the

intersection, sitting just past the marked stop bar for the stop sign on east bound Hidden Cove RD. Vehicle 1 came to a rest facing south, next to the same guardrail, approximately eight meters further south of Vehicle 2.

Both Vehicles had full airbag deployment and sustained major damage to their front ends. The driver of Vehicle 1 was unconscious upon our arrival, and was transported by airlift to Harborview in Seattle for loss of consciousness and chest pain. The driver of Vehicle 2 was evaluated by aid on scene after complaint of injury, he was transported by aid to Saint Michael Medical Center in Silverdale for a suspected concussion.

Ofc. Bingham observed that the driver of Vehicle 1 was sweating profusely while unconscious, and suspected impairment. While collecting identifying information for the vehicle and driver, I observed numerous articles of marijuana paraphernalia in open and plain view. There was a strong odor of Marijuana in the vehicle. Ofc. Swan collected two evidentiary samples of blood from the driver of

Vehicle 1 for suspected driving under the influence of intoxicating drugs. Both Vehicles were impounded.

The witnesses both stated that they were at the stop sign on west bound Hidden Cove at SR 305 in the same vehicle. They stated that they were next to Vehicle 1, which they knew to be intending to cross SR 305. The witnesses are coworkers of the driver of Vehicle 1 and know he lives just across the intersection. The witnesses stated that they saw a break in traffic, and pulled onto SR 305 to

cross SR 305. The witnesses are coworkers of the driver of Vehicle 1 and know he lives just across the intersection. The witnesses stated that they saw a break in traffic, and pulled onto SR 305 to travel north. They stated that they heard a loud pop, and looked behind them to see the collision had occurred. The witnesses stated that there was a vehicle in the left turn lane on south bound SR 305 to pull onto east bound Hidden Cove. They stated they did not see vehicle 2 behind it.
